Subject: CONFLICT MINERALS declaration

In relation to Regulation (EU) 2017/821 of the European Parliament and of the Council of 17 May 2017 (Official Journal of the European Union L130 of 05/19/2017) which establishes obligations regarding duty of due diligence in the supply chain for Union importers of tin, tantalum and tungsten, their minerals, and gold, originating from conflict-affected or high-risk areas, our suppliers of phosphor bronze contacts, the only component used in our products involving the use of minerals included in the above regulation, declare to support the fight against violence, human rights violations and the environmental degradation due to the extraction and marketing of these minerals or other derivatives of the geographical area defined as a "Conflict Region", which includes the Democratic Republic Congo (DRC) and neighboring countries.

Their raw material suppliers state that they do not source minerals directly from mines and foundries, but have begun to undertake a "Due Diligence" process with their own suppliers to ensure the non-use of minerals from the conflict-mineral region and yes they undertake not to deliberately procure minerals that come from local mines called "Conflict Region".

LTE srl fully supports this law and our position is to avoid suppliers who they use minerals that are not certified as "conflict free".

Our suppliers declare that the material used to manufacture our products DO NOT CONTAIN minerals ("conflict minerals") from the following countries:
